Background of the NDF (1/2) 國發基金背景

- 一、 The Executive Yuan founded the National Development Fund (NDF) in 1973.

- 二、 The goal of the NDF is to speed up industrial transformation and to boost economic growth.

- 三、 The NDF has carried out industrial policies through direct equity investment, venture capital investment, loan financing and subsidy programs.

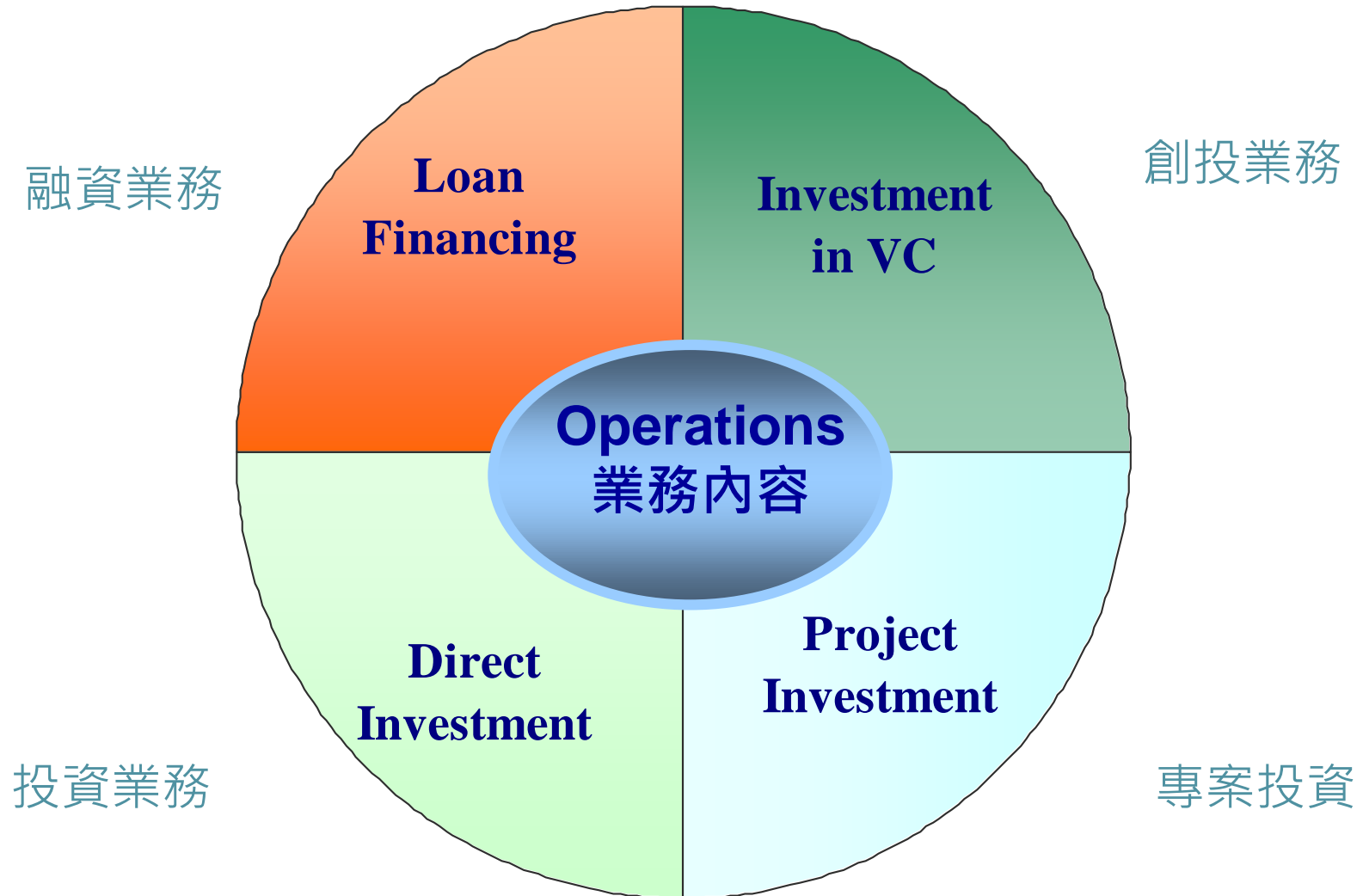
國發基金藉由直接股權投資、投資創業投資事業、提供融資及專案投資方式執行政府產業政策。

四、The NDF primarily invests in biotechnology, aerospace, optoelectronic, semiconductor, transportation, telecommunication, information and software, digital content, and creative sectors.

直接投資之投資策略原則

1. Do not act as lead investor

原則上 **不擔任主導性投資人**

2. Invest in fund raising projects with raising amount above NT\$ 500 million

當次募資總金額 **超過新台幣5億元**

3. Participate in projects that government shares in aggregate is not over 50%

公股比例合計 **不超過50%**

4. Invest in non-listed companies on TWSE or OTC

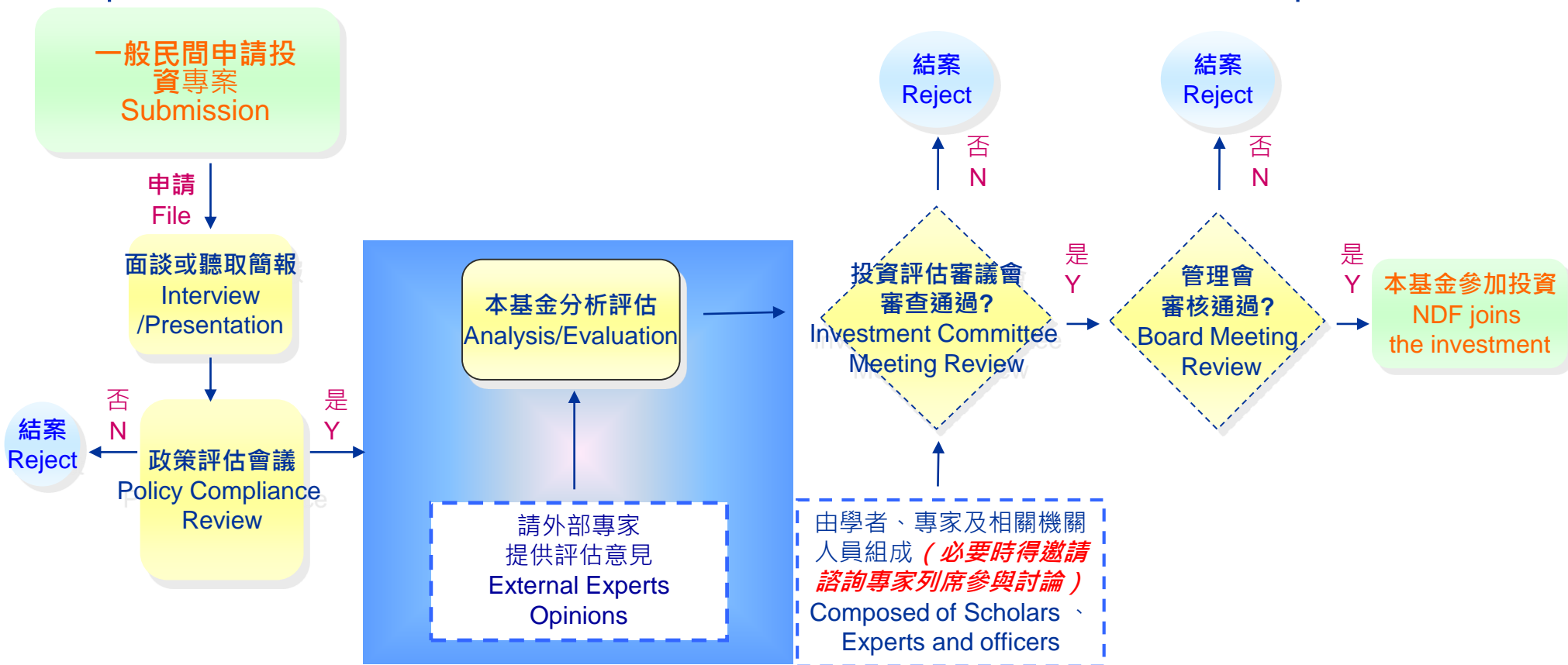

專案投資之投資策略原則

1. Co-investment with management consultant company

與管理顧問公司搭配投資

2. Invest in company raising projects with raising amount less than NTD\$ 500 million

當次募資總金額不超過新台幣5億元

3. Participate in projects that government shares in aggregate is not over 50%

公股比例合計不超過50%

4. Invest in non-listed companies on TWSE or OTC

創業投資之投資策略原則

1. Investment in a single VC shall not exceed 30% of the VC's Paid-in capital and may not exceed NT\$1 billion dollars.

本基金對個別創投事業之投資，以不超過10億元或募資基金總額30%，孰低為限

2. The amount of investment in Taiwan related enterprises from the VC invested by the fund shall reach at least the total amount invested by the fund.

創投事業投資於我國相關企業之金額至少應達本基金投資之總金額

3. NDF delegates Megabank to invest in VC by a deed of trust.
